DRAFT MINUTES

Parish Council EXTRAORDINARY Meeting St Ewe Village Hall, 7.00 PM Monday 23 APRIL 2018

The meeting began at 7.02 pm and the Chairman welcomed all.

17/121 Apologies

Apologies were received from AB, TJ, DC and MF.

17/122 Councillors' interests

- A) Declarations of interest. None
- B) Request for dispensation. There were no requests.

17/123 Public Session

Helen Nicholson, Community Link Officer for the St Austell and Mevagissey Community Network Panel (CNP) spoke about the Community Network Panel (CNP) Highway Scheme and its procedures. For a total of four years, the Scheme has a budget of £50K per year per Community Network for highway improvement schemes (traffic calming, pavements, etc) not for highway maintenance.

Helen requested a list of Highways issues from the Parish Council before the middle of May. At the CNP's next meeting the issues will be discussed, prioritised and voted on. Issues, not solutions, are requested because highways experts will look at the best way to solve the issues.

St Ewe is a member of the St Austell & Mevagissy CNP, which includes:

- 8 parish councils including St Austell Town Council: Mevagissey, St Ewe, St Goran, St Mewan, Pentewan Valley St Austell TC, Carlyon, and St Austell Bay
- There are 7 Cornwall Councillors representing the area covered by the CNP.
- Each parish has a vote and each Cornwall Councillor has a vote, totalling 15 votes.

Helen also advised, that St Ewe and the other parishes in the Community Network will have to coordinate their efforts in order to use the relatively small budget well over the 4-year period. If the scheme is a success, it will be repeated. If CNPs cannot come to equitable decisions, the Scheme might not be repeated.

17/124 Meetings and governance

- A) Previous Actions for report. All actions are complete except a second quote for footpath maintenance.
- B) The council **RESOLVED** that the minutes of the meeting held on 12 March 2018 were a true and correct record (proposed TH, 2nd JD) and they were duly signed.
- C) The clerk gave a brief report on the General Data Protection Regulations coming into effect from 25 May. Most importantly, the ICO has explained that it is an ongoing process which must have begun by that date, though it won't be completed on that date.

17/125 Finance

- A) The council reviewed the end of year figures and earmarked funds (reserves) in the Budget Comparison, Cash Flow, Bank Reconciliation and the Year-end Financial Briefing Note. It was **RESOLVED** to accept these as a true and correct record of the 2017-18 financial year and to approve the placement of the Year-end Financial Briefing Note on the website with the other accounting documents, which are there in compliance with the Transparency Code (proposed WR, 2nd JD).
- B) The clerk reported on a rise in the hourly rate for NJC spinal column points from April 2018, to which her salary is fixed.
- C) It was **RESOLVED** (proposed JD, 2nd WR) to continue membership in the Cornwall Association of Local Councils (CALC). Payment will be made at the next ordinary meeting in May.

17/126 Considerations

A) Possible Neighbourhood Development Plan (NDP). The council discussed at some length the pros and cons (for example: the pros are that there would be more control over development in the parish and a difficulty would be the time, effort and dedication required to put a NDP together. Helen Nicholson and Cherilyn Williams had very helpful information as both have worked on Neighbourhood Plans for their areas. For example, currently in planning law there are no settlement boundaries, but an NDP for St Ewe could set up settlement boundaries. Helen did explain that the Parish Council may not start the process without evidence from the community that St Ewe wants an NDP. Helen offered to ask planning colleagues to outline what planning policies in the Cornwall Council's Local Plan are relevant for St Ewe parish. She also offered to come to a future meeting to give a presentation on Neighbourhood Plans. The skill mix within the NDP steering group is important too. It would be most helpful to recruit someone who has the skills to be a project leader, someone who can set up presentations with photos and maps. Skills like these would help the project progress in good time with good community engagement.

H Nicholson left the meeting.

B) Footpath maintenance. It was **RESOLVED** (proposed WR, 2nd JL) to accept the quote from GET Landscaped and the council will also get contact details of other contractors in the area to get more than one quote for next year's maintenance.

17/127 Planning.

- A) It was **NOTED** that the application, PA18/00499, for outline planning permission on glebe land next to the Village Hall was WITHDRAWN for further consultation with the parish.
- B) Correspondence. A letter from Dominic Raab MP regarding a consultation on unauthorised developments and encampments was **NOTED**.
