- B The online meeting ID Number and Password will not be published online or on notice boards, but will be available from the clerk on request.
- C The council may hold meetings at any time of day and on any day, to alter how frequently meetings can be held and to move or cancel meetings without requiring further notice.
- D The agenda for any meeting at which decisions are made will be posted on the council website and the notice boards 3 clear days before the meeting.
- E Voting will be non-verbal using electronic icons on screen or as instructed by the chairman.
- F In accordance with government regulations and guidelines, the council may extend these emergency measures or revoke them before 7 May 2021.
 - b) To agree that: That the Council delegates authority to the Clerk in consultation with the Chairman and Vice Chairman to take any actions necessary with associated expenditure to protect the interests of the community and ensure council business continuity during the period of the pandemic Coronavirus, informed by consultation with the members of the council. Decisions made in this manner will be noted in *The Register of Delegated Decisions* which will be posted on the parish website under *Other Policies*.
 - c) To consider training for the clerk for better compliance with the website accessibility regulations: SLCC Webinar: Creating Accessible Word and PDF Documents. £30 + VAT
