# Extraordinary Meeting, MONDAY 11 OCTOBER 2021 7.00 pm, St Ewe Village Hall

#### **MINUTES:**

The meeting began at 7.00 pm and the Chair welcomed all.

### 21/72 Apologies

Apologies were received from AG, MH & PS.

21/73 Declarations of interest or requests for dispensation.

### 21/74 Public Session

A WILDFLOWERS in the verges. The Chairman took advantage of the number of people attending to explain the council's proposal to change the cutting schedule of the verges in St Ewe village (only those verges maintained by the parish council) in order to encourage wildflowers. The Chair asked those from the village to contact the clerk with their views as to whether it would be a good or a bad thing to do. The council will decide whether to go ahead with the change at its 8<sup>th</sup> November meeting.

The items at 21/75 were considered here and then the Public Session continued. See the decisions at those items.

B Discussion about PA21/08050 (Outline application for up to nine dwellings). The Chair allowed one hour so that all those present had an opportunity to speak. The architect for the project attended and answered questions from the council and members of the public. Consideration of consultee comments on this application (Item 21/77.C.i) was brought forward. See the decision at that item.

Twenty-three members of the public left the meeting.

C Two employees from The Lost Gardens of Heligan explained the planning application and the council was able to ask questions about PA21/08366 (Refurbishment traditional tearoom and event space | Stewards House, Heligan). Consideration of consultee

comments on this application (Item 21/77.C.iv) was brought forward. See the decision at that item.

# 21/75 Meetings and governance

- A The council **RESOLVED** (proposed TT, 2nd WR) that the minutes, as read, of the meeting on 13 September 2021 were a true and correct record and they were duly signed.
- B The council **RESOLVED** (proposed JD, 2nd TT) to approve the Clerk's training with SLCC, Budget Basics, at a cost of £30, to be shared with her other council.
- C The resignation of Cllr Tracey Jenkin was **NOTED** and the NOTICE will be posted by Friday 15 October. Unless a by-election is requested, the co-option of a new councillor will be possible at the 8th November meeting. # 21/77 Planning

A Planning Correspondence. It was **AGREED** that the councillors would respond individually to the Cornwall Housing Strategy informal consultation. It requests views on the challenges faced around the housing market in Cornwall and what Cornwall Council's priorities and objectives should be moving forwards. - C Applications for consultee comments.
  - PA21/08050 | Outline application with some matters reserved for rural exception site for up to nine dwellings and associated landscaping works | Land North East Of Glebe Cottage St Ewe St Austell Cornwall PL26 6EY.

The council NOTED many emails from local residents about this application, with two in favour and all others objecting. At this meeting, the council heard from members of the public and all had the chance to ask questions from the architect who also attended.

After discussion the council **RESOLVED** (proposed WR, 2nd JL) to submit the following consultee comments:

- \*\*\* After lengthy discussion, having asked numerous questions of the architect and after considering all the points raised by members of the public, St Ewe Parish Council OBJECTS to this application for the following reasons:
- 1) SEAHL (St Ewe Affordable Housing Ltd) delivered 6 affordable houses approximately 10 years ago and is actively looking for space for 3-4 more; however, it may not be involved with a mixed open market /affordable scheme. SEAHL was not consulted by the applicant; neither was the community or parish council consulted, as suggested in the Pre-app Advice: "It is recommended that the local ward member and Parish Council are consulted at the earliest opportunity in order to discuss the proposals and local housing need."
- 2) The first principle for a rural exception site is that it is 100% affordable. A Financial Viability Report to explain the reasoning behind an offer of only 55% affordable homes is not in the applicant's documents and this is an important oversight.
- 3) Highway Access. In the opinion of the majority of St Ewe residents, the access point, which is the only permanent part of this outline proposal, is seriously flawed. Visibility at that point is extremely poor. A significant amount of Cornish hedge would have to be removed to make this access safe. The council does not believe that Highways' approval of the access point took this into account.
- 4) Water runoff. Not only residents in St Ewe object to this application. Properties and highways downstream of the site on the River Luney would be at greater risk of flood. Though the architect explained various ways that water runoff could be controlled, Sustainable Urban Drainage Systems have been notoriously difficult to maintain and the Polmassick Culvert, put in a few years ago by Cormac would be under more strain. The slope of the proposed field would lead to a significant amount of water threatening properties downstream.
- 5) Topography and location. Development of this site would over-pressure existing sewage treatment, pose serious water run off issues, mean very significant civil engineering to enable construction and result in a significant negative environmental impact.
- 6) Traffic and parking. The proposed two car spaces for each dwelling are woefully insufficient. Many modern households with a child above driving age will have 3 cars. This causes problems everywhere, but St Ewe village has had a parking problem for years and this application does not address this. Traffic through St Ewe is congested now and a 30% increase in the size of the village will only exacerbate this.
- 7) Sustainability. St Ewe no longer has the amenities of a post office or local shop as it once did, nor does it have a public transport link as stated in the application.

Basic shops are some distance away. Expanding the village by this number of houses is not sustainable.

- 8) Enclave development. St Ewe village is traditionally laid out with many listed buildings and with most houses facing the road. Significantly increasing the size of the village with an 'enclave' development is out of keeping with the vernacular.
- 9) Greenfield site. Over 20 members of the public attended the council's meeting to discuss this application and the advantages of a few affordable homes were weighed against the disadvantages of this site. The majority of St Ewe residents are against this development and the Parish Council's decision to OBJECT reflects this view. On balance, the benefit of a few affordable homes does not outweigh the loss of a greenfield site, for all the reasons stated here.
- ii. PA21/08341 | Renovation, reconfiguration and extension | Tregear House Tregear Hill St Ewe St Austell PL26 6EZ.

\*\*\* St Ewe Parish Council has noted the comments from Historic Environment Planning and Historic England and understands that the alterations to the property are subject to the approval of the conservation officer. St Ewe PC has NO OBJECTION to this application.

- A JL reported that the Polmassick Culvert will be dredged of silt by the end of this month. Cormac originally reported that it was not necessary, but this was countered by JL's photographs. We think the Cormac employee may have inspected the wrong culvert.
