The meeting began at 7.45 pm and the Chair welcomed all.

22/1 Election of the Chair.

The council **ELECTED** (proposed TT, 2nd JL) Cllr Will Richards as Chairman of the Parish Council and Cllr Richards signed his Declaration of Acceptance of Office.

The council **ELECTED** (proposed TT, 2nd PC) Cllr John Dickinson as Vice-chairman of the Parish Council and Cllr Dickinson signed his Declaration of Acceptance of Office.

22/3 Apologies

- B The council **RESOLVED** (proposed WR, 2nd JL) to accept the apologies from Cllr M Howell for the meetings today and for the July meeting because of family matters.

- 22/7 Declarations of interest or requests for dispensation.
 - A WR declared an interest in the grant funding for the Village Hall as he is on the management committee.
 - B JD declared an interest in the planning application PA22/01979 as he is a neighbour.
 - C PV declared an interest in the planning application PA22/02770 at his property.
 - D Cllr Lockyer is a member of the Village Hall management committee; however, her dispensation for decisions concerning the Village Hall is in place until the 2025 election (Minute 21/20.B)

22/8 Public Session

A resident at Tucoyse explained that a static caravan has been delivered to a plot of agricultural land nearby which appears to be a breach of planning. This has been reported to the enforcement team at Cornwall Council and the resident asked for support from the parish council. It was noted that there had been an application for a

- holiday dwelling on the land which was refused in 2014. On appeal to the planning inspectorate, the appeal was dismissed. (See Minute 22/13)
- B A member of the public came to show the council the plans for building three family homes on land at Polmassick. He and his siblings have consulted with neighbours and want to work with the parish council towards an acceptable design, in keeping with the surrounding area. The full application will be submitted in the next few months.

Cllr Bunney asked that the storm drain on the road in front of the proposed development be taken into consideration if the project goes ahead.

JL asked that the development consider efficient Sustainable Drainage Systems (SuDS) so the houses downslope in Polmassick are not affected by runoff from the buildings and drive.

Two members of the public left the meeting.

22/9 Meetings and governance

- A The council **RESOLVED** (proposed JD, 2nd TT) that the minutes, as read, of the meeting on 14 March 2022 were a true and correct record and they were duly signed.
- B There was no proposal to respond to the NALC Direct Funding Survey.
- C It was **AGREED** that street naming in Cornwall should reflect the history and Cornish place names of a site where possible and the Clerk will reply to the 'Technical consultation on street naming'.

- A The council **RESOLVED** (proposed JD, 2nd PV) that it would grant £700 to the maintenance of All Saints' churchyard.

- C The council **RESOLVED** (proposed PC, 2nd PV) that it would grant £550 for St Ewe Village Hall maintenance.

- The council **RESOLVED** (proposed WR, 2nd JD) that the allocation of reserves at the 2021/22 Year End and the beginning of the 2022/23 fiscal year stands: Contingency Reserve £2,560.84; Election Reserve £3,345.00; CIL (Community Infrastructure Levy) Grant £1,748.78; Climate Action Group Project Grants £40.62; Transparency Fund 2018-19 Grant £109.40; Aura Wind Turbine Fund £1,017.60; St Ewe Defibrillator Fund £400.04; Emergency Fund £169.50; Heligan Grant for Jubilee £250.00. Total: £9,641.78.
- F The council **RESOLVED** (proposed WR, 2nd JD) to approve the Audit figures for the Annual Accountability & Governance Return (AGAR) and the AGAR Explanation of Variances.
- G The council **RESOLVED** (proposed JD, 2nd TT) that it would not be audited externally. All audit (AGAR) documents will be posted on the parish website under *Council Accounts* before 1st July 2022 along with other accounts documents.

- H The council **RESOLVED** (proposed WR, 2nd JL) that it would again subscribe to the Cornwall Association of Local Councils (CALC) at £309.81 incl VAT.
- I The council **RESOLVED** (proposed PC, 2nd PV) that the council would renew its insurance with Zurich Municipal Insurance for a 3-year long term agreement at £390.94.

- ii. The council **RESOLVED** (proposed JD, 2nd TT) to send the details of the new caravan and building works at Tucoyse to the enforcement team and mention the previous refusal in June 2014 for **PA14/03225** and the subsequent dismissal of the appeal in 2015: APP/D0840/W/14/3001048.

iii. PA22/01404 | Erection of agricultural machine store and associated ground works. | Agricultural Barn At Tredici Farm Tregony Truro TR2 5SH.

Though in Grampound with Creed Parish, this proposed development will have a strong visual impact on residents in St Ewe Parish. St Ewe therefore discussed the application. Cllr Bunney reported that a site visit was planned for the next day and St Ewe councillors were welcome to attend. He also reported that the Grampound with Creed Parish Council has objected to the application because it is out of proportion to the agricultural need and the visual impact on the rural area will be overwhelming. The council **RESOLVED** (proposed PC, 2nd JL) to submit the following comments in support of the residents at Tucoyse and Grampound with Creed PC:

*** St Ewe Parish Council agrees with and supports the further consultee comments of Grampound PC to OBJECT to this application. The proposed agricultural machine store will have an adverse visual impact on residents in St Ewe Parish. It is out of proportion to the agricultural need of this small plot and will be an overwhelming modern structure, out of keeping for a smallholding in an otherwise traditional rural setting. St Ewe Parish Council OBJECTS to this.

PV left the chamber for the duration of the discussion and vote on the next item 22/13.C.i.

 PA22/02770 | Construct garage and extend the residential curtilage with modifications to existing access | Trevithick Farm, The Loft Access To Trevithick Farm Tregony TR2 5SL.

The council discussed the application and **RESOLVED** (proposed WR, 2nd PC) to submit the following consultee comments:

*** St Ewe Parish Council has NO OBJECTION to this application.

JD left the chamber for the duration of the discussion and vote on the next item 22/13.C.ii.

ii. PA22/01979 | Proposed demolition of existing reception, facilities and function building and the erection of replacement reception room, and plant room, provision of additional holiday letting/owners accommodation over. | Lower Barn Guesthouse Road From Trelean Vean To Rescorla St Ewe St Austell PL26 6ET.

The council submitted its objections to this application in March this year. However, it noted the concerns of a local resident about some newly submitted photos of the development and agreed that the photos are misleading because they do not show the proposed development to scale. It is the size of the building that is the basis of major objections by neighbours and the parish council.

The council **RESOLVED** (proposed PC, 2nd WR) to submit further consultee comments:

*** St Ewe Parish Council continues to be concerned about the scale of this development and endorses the opinion of the neighbours that the proposed building is too large. The recently submitted photos do not show the proposed development to scale and are therefore quite misleading. The large windows could not be sufficiently concealed by vegetation and would cause considerable light pollution at night which would drastically change the character of this tiny rural hamlet of Bosue.

22/14 Highways & Flooding

- A Highways Scheme. The 20 mph zones will be put in place for St Ewe village and Polmassick. However, the criteria are not met for Hewas Water or Pengrugla.
- B Consideration of traffic control in Hewas Water is **DEFERRED** until a meeting when the local councillor and/or residents of the area can attend.
- C Consideration of traffic control in Luney Lane along with the Speed Monitoring Report is **DEFERRED** until a meeting when the residents of the area can attend.
- D AG reported that there is a rare pink garlic in the verges at Pengrugla which in the past has been strimmed by Cormac. The Clerk requested that the verge is not strimmed until the garlic has seeded. Cormac was not aware that this variety appears in June, later than the ordinary white garlic. AG's photos of the pink garlic have been sent to Highways.
